Registration as a Scrutineer/Professional

Registration Period 1st July 2022 - 30th June 2023

Conditions of Registration

1. *To be registered with the Australian Dancing Board as a professional each applicant must have achieved one of the following standards:*
 - a) *Gained a teaching qualification (Associate, Licentiate/Member or Fellowship) in a least one of the four listed ballroom styles*
 - b) *Passed the Professional Entrance Examination*
 - c) *Gained recognition as a professional by means of one of the Discretionary Clauses.*
 - i. *Gained a teaching qualification with an overseas society and is currently a member of that society.*
 - ii. *Competed overseas as a professional.*
 - iii. *Been elected to the Executive or Committee of Management of an Australian Dancing Board Recognised Society in accordance with the constitution of that society.*
 - iv. *Competed as a registered competitor in an Australian Dancing Board registered professional competition in Australia.*
 - v. *Has otherwise, by reason of his/her character, antecedents and or experience, gained in the opinion of the Australian Dancing Board the requirements of registration.*
2. *To be registered with the Australian Dancing Board only as a scrutineer (the first listed category on the front of the form), the applicant must hold a Scrutineer Licence issued by the Australian Dancing Board.*
3. *By signing the declaration on the front of this form the applicant acknowledges that:*
 - a) *The annual registration fee (as fixed by the board of the Australian Dancing Board from time to time) is due payable before 1st July in each year.*
 - b) *The registration will extend from the date payment is received by the Australian Dancing Board until 30th June in each registration year.*
 - c) *Registration will lapse automatically if registration fees have not been received by 30th June in each year.*
 - d) *A receipt will be issued on payment of fees.*

Notes

- I. *Each person registered with the Australian Dancing Board as either a professional or a scrutineer has been issued with a professional or scrutineer registration number. Please record this number in the appropriate place on the front of this form,*
- II. *With the exception of the first listed category of registration "ADB Registered Scrutineer" on the front of this form, completion of this form implies the acceptance of the person so registered of his or her status as a Professional Ballroom Dancer.*
